## About the Industry Default Standard Rates

The Water Industry Commission for Scotland, the industry regulator, has determined a set of standard conditions for the purposes of granting water services licences and sewerage services licences under the Water Services Etc (Scotland) Act 2005 (**the standard conditions**).

Under condition B1 (Duty to provide default services), each licensed provider to whom that condition applies is obliged in certain circumstances to offer to provide certain retail services (known as **default services**) to a particular standard (known as the **default standards**) and at a price not exceeding a maximum amount (known as the **default maximum tariffs**).

*Under Brightwater's 'DST minus tariff', the rates under the industry's default standards (DST) for 2022/23 are discounted by a fixed percentage for all services. The level of discount available depends on the services provided to your premises, the level of consumption and your Rateable Value*

*For example, a DST-15 tariff would apply a 15% discount to the current industry's default standard rates.*

## Water Services

Water services consist of four main elements

- Water – the supply of clean water to your premises
- Wastewater – the disposal of waste / foul water from your premises
- Drainage – the removal of rainwater (surface water) from around your premises
- Trade Effluent – the removal of any liquid waste produced in the course of any trade or industry

### Water Services

This covers the supply of clean water to your premises and is broken down into two elements

#### Fixed charge

This is an annual fee for your connection to the Scottish Water water network. If a water meter is connected to the premises the fixed charge is determined by the size of your meter. Unmeasured premises have a fixed connection fee.

#### Volumetric charge

A charge for the supply of water supplied to your premises each year

- Metered premises – this charge is based on the volume of water recorded by your meter(s) and is charged per m<sup>3</sup> (1,000 litres).
- Unmetered premises – this charge is based per on the Rateable Value (RV) of your premises

### Wastewater (Sewerage) Services

This covers the removal of foul water from your premises and is also broken down into two elements

### **Fixed charge**

This is a yearly fee for your connection to the Scottish Water sewerage network. If a water meter is connected to the premises the fixed charge is determined by the size of your meter. Unmeasured premises have a fixed connection fee.

### **Volumetric charge**

This is a charge for the volume of foul water removed from your premises. As standard Scottish Water assume the wastewater volume returned to sewer is 95% of the water supplied to your premises.

- Metered premises – this charge is based on the volume of water recorded by your meter(s) and is charged per m<sup>3</sup> (1,000 litres).
- Unmetered premises – this charge is based per on the Rateable Value (RV) of your premises

## **Drainage Services**

These charges contribute to the removal and treatment of surface water from within the boundary of your property, including private roads and car parks. Charges are based on the Rateable Value (RV) of your premises.

**From 1 April 2021, the separate property & roads drainage charges will be replaced by a single drainage charge. This single drainage charge will only apply at premises that have a property drainage service.**

This will continue to be termed “Property Drainage”; however Scottish Water intend to rename these services later.

## **Trade Effluent Services**

Trade effluent covers any liquid produced in the operation of any trade or industrial process that is discharged to the wastewater system.

It includes water used in production, washing, or cooling facilities, and covers both large and small premises, including businesses, such as car washes and launderettes. Discharges from hotels, caravan sites or restaurants are not considered trade effluent.

### **Availability Charge**

The availability charge is an annual fixed charge based on the maximum amount of effluent to be discharged each day the strength of the effluent and the amount of solid material in the effluent, as specified in the trade effluent consent.

### **Operating charge**

The operating charge is a volumetric charge based on the actual volume of effluent discharged from the site, its strength and composition

- CDV = Chargeable Daily Volume (as per trade effluent consent)
- sBODI = settled Biochemical Oxygen Demand load (as per trade effluent consent)
- TSSI = Total suspended solids load (as per trade effluent consent)

$$\text{Operating Charge} = \text{AVD} \times [\text{Ro} + \text{Vo} + \text{Bo} \times (\text{Ot}/\text{Os}) + \text{So} \times (\text{St}/\text{Ss})]$$

- AVD = Actual Volume Discharged
- Ot = fixed strength (settled chemical oxygen demand) of the discharged effluent
- St = fixed strength (settleable solids) of the discharged effluent
